

## Saiber Receives High Rankings in Chambers USA 2025 Edition

The 2025 edition of *Chambers USA* has ranked Saiber LLC and eight of our attorneys within the General Commercial Litigation, Gaming & Licensing, Intellectual Property, Corporate/M&A, Environment, and Real Estate categories.

In the Nationwide Gaming & Licensing table, Saiber's gaming law practice ranked nationally as a Band 2 Firm.
