

## **Privacy Policy**

Thank you for visiting the website of Saiber LLC ("Saiber"). Saiber takes your privacy seriously and has adopted this Privacy Policy to inform you about our practices regarding the collection, use and sharing of information. This Privacy Policy applies to information that we collect from you when you visit our website.

Saiber receives and stores both personal information (i.e., information from which a user may be personally identified), and non-personal information (i.e., information that does not identify the specific user).

Saiber collects information in the following contexts and uses that information for the following purposes:

If you sign up for to receive Saiber alerts, e-newsletters or other publications, we will collect your name, email address and, if applicable, other contact information. We collect that information when you voluntarily input it into our website. We use that information to provide you with the publications for which you have signed up. In order to more efficiently provide you with these publications, we may share your personal information with a third party vendor which specializes in managing contact lists and transmitting publications and client alerts.

If you choose to apply for a position at our firm through our website, you may provide us with your name, address, email address, telephone number, resume and other application materials through the website. We will use that information to evaluate your application for employment and to contact you with regard to your employment application. We use Google Analytics, an automatic data collection technology, to collect information about how a visitor to our website uses and interacts with our website. We are unable to use the information provided by Google Analytics to identify any individual users of our website. A cookie is a small file placed on the hard drive of your computer. - Other disclosures without your consent. We reserve the right to disclose your personal information if we reasonably believe that we are required to do so by order of a Court, court procedures or under law.

You may make the following choices regarding your personal information:
